

The Good Earth Food and Wine Co. Inc. – The Good Girth Contest Official Contest Rules

To enter, visit www.goodearthfoodandwine.com, click the contest button, fill in the required information and submit the form as directed. Entrants will be required to provide complete first name, last name, email address, phone number, postal code and opt-in to electronic communications from The Good Earth. Limit one entry per person, household, or e-mail address. Multiple or duplicate entries may be disqualified. Entries become the property of The Good Earth and will not be acknowledged or returned. ALL ENTRIES MUST BE RECEIVED BY MARCH 31, 2019.

5. CONTEST CLOSING DATES & WINNER SELECTION: On or around November 1, 2018 and April 1, 2019 in Beamsville, Ontario ("ON"), a random draw will be conducted from all eligible entries received. Odds of winning depend on the number of eligible entries. Contest entrants agree to be bound by the terms of these Official Rules and by the decisions of the Sponsors, which are final and binding on all matters pertaining to this Contest. All final decisions are in the sole discretion of the Sponsors.
